## Optional Fees for Interment

*Additional fees may be changed for special requests or accommodations requiring additional care at the burial site. May require one or all of the following:*

- **Cemetery Attendant:** Ivy Lawn requires a funeral guide at every burial. The security and safety of visitors is considered, also parking and monitoring of guest's needs, offers guidance to family, directions, time frames, and communication..... **\$250.00**
- **Parking Attendant:** Location and logistics of guests is significant as the cemetery has limited parking, limited road access, and has one-way streets to monitor. Safety is of utmost consideration. When determined by the cemetery, based on descriptions from the customer, we may require a parking attendant or more than one attendant. .... **\$200.00**
- **Safety Attendant:** If safety issues are determined the cemetery may require an attendant to observe and advise arrangements for comfort of guests, and efficiency of the burial. This may require more than one attendant..... **\$200.00**
- **Extra Time:** If special arrangements are needed, and the family has requested additional time added to the one hour allotted time, Ivy Lawn will accommodate the request. Because extra time accommodations likely create special arrangements, there will be an additional charge for extra time at the burial site. The charges start by adding an extra hour..... **\$400.00**

**Every burial is allotted one hour of uninterrupted time at the burial site. LOWERING of the casket or urn will be planned at the 1/2-hour mark. Cemetery crew will automatically lower the casket or urn at that time. We expect the family to continue for the remaining time. We welcome guests to place flowers and adornments on the casket after It is lowered. The burial concludes at the end of the hour and after ALL guests have left the area. The grounds department will prepare to close the grave and follow procedure with the use of heavy equipment. At this time the lawn area will be attended to and prepared for future growth and beauty of the site.**

**PLEASE NOTE THAT THE EXTRA TIME WILL NOT AFFECT THE LOWERING TIME WHICH WILL ALWAYS BE AT THE ½ HOUR MARK OF THE START OF THE SERVICE.**
